### **About digitization of works / digital exhibition:**

*Living Archive is an interactive dissemination project with the following main focus areas:*

1. Collection of oral narratives from queers about their contemporary lives through in-depth interviews.
2. Physical and digital collection and dissemination of the "Banned Books Library" project.
3. Digitization of works for exhibitions in 2024 onwards.
4. Curation of physical and digital exhibitions that highlight the works and individual artistry on an equal footing with co-created works and co-creation as a method.

The purpose of digitizing works is to make the works easily accessible to the public all year round, as well as to ensure a good framework for the digital dissemination of works and artists through the curation and composition of works and other content. Other content may include artwork created with other materials, artwork created by other artists, and/or interviews with artists and/or audience members.
